- () **(1) New or transferred contract**
I hereby grant permission for my child (or the minor in my care), named on the left, to enter into a service contract based on AU telecommunication service agreement clauses. This includes various agreements concerning change of price plans, change of model, and AU telecommunication services (excluding change of phone numbers and change/termination of filtering services such as Safety Access Service). ★If the applicant has agreed to purchase a mobile phone via installment plan, I agree in advance to pay any remaining unpaid amount in a lump sum at the end of the agreed upon term. ★If the applicant pays for AU telecommunication service usage fees with my credit card, I claim responsibility for payment. [Note] 1. If the applicant is 12 to 19 years old, the parent/guardian must sign each application form or this document of consent. 2. After receiving a signed application for a new contract with a minor, (or handover of utilization rights), the service provider will send the official letter of confirmation to the parent/guardian and may also call the parent/guardian for confirmation. 3. To make monthly payments using the parent's/guardian's credit card, the applicant must be less than 20 years old and be accompanied by the same parent/guardian at the time of application. 4. This document of consent is only effective if accepted within 1 month of being signed. 5. Any false information in the contract (name, address, contact address, etc.) may be cause for cancellation of the contract.
